The NACS ADM student count is estimated to grow about 200 students in 2022-23 and it grew by 86 students in 2021-22, 11 students in 2020-21, 134 students in 2019-20, 146 students in 2018-19, and 198 students in 2017-18. NACS plans to purchase three additional 78-passenger conventional school buses, budgeted at \$474,000.00, to accommodate the student growth the district has had and anticipates in the future.
